



DEE WHY SLSC COMPETITORS INFORMATION

Part A: Carnival Fees and Competition Levy

1. Nippers:

- a) A competing/training nipper is classified as U9 to u13
- b) The total levy is \$100 for any nipper that attends any carnivals
- c) Includes entry to ****all** carnivals sanctioned by the nipper committee
- d) Includes access to all training sessions, beach, swim, and board sessions
- e) No competitor will be entered into a carnival unless the levy is paid
- f) If a competitor misses a carnival and is unable to give a satisfactory reason, they will be required to pay the entry fee prior to be entered into the next carnival
- g) There is no pro-rata for the levy, the levy is applicable for 1 or more carnivals or competitive sessions
- h) If a member has extenuating circumstances, financial or otherwise, they may apply to the committee to waive the levy

****SNB** and out of branch carnivals such as Sydney water and Newcastle permanent as deemed a sanctioned carnival by the committee.

2. Active Patrolling Members/ Long serving Members / Coaches:

Defined as an active rostered patrolling member (including U14 SRC members) at Dee Why that must comply with the competitor patrolling rules as documented, or a long service member that has done in excess of 8 years' service for **DEE WHY**, or a qualified coach actively coaching Dee Why members.

Does not include those with long service from other clubs or competition transfers.

- a) \$30 Levy
- b) ****All** carnival entry fees paid by the club
- c) You must fulfil your patrolling requirements as per patrolling requirements v1.1 document on the DYSLSC website if you are an active patrolling member
- d) No competitor will be entered into a carnival unless the levy is paid
- e) If a competitor misses a carnival and is unable to give a satisfactory reason, they will be required to pay the entry fee prior to be entered into the next carnival
- f) There is no pro-rata for the levy, the levy is applicable for 1 or more carnivals or competitive sessions
- g) If a member has extenuating circumstances, financial or otherwise, they may apply to the committee to waive the levy

**** Payment** by the club of external events such as Ocean Thunder and Coolangatta Gold will require committee approval and may require fundraising and sponsorship to offset costs.

3. Competition Transfers / Non-Patrolling Members:

Defined as a member that is not allocated a rostered patrol at Dee Why.

- a) \$30 Levy
- b) Must pay own entry fee to all carnivals.



Part B: Gear and Equipment Storage

1. Nipper Club Members:

A nipper that is financial, competing and regularly training for the club that has paid their competitor levy for the season may store their board in the Nipper cage at the discretion of the Nipper head coach and Gear steward pending available space.

2. Senior Club Members

- Patrolling Members (Active/Active Reserve) may store their board and or ski in the board and ski area at DYSLSC free of charge under the following conditions:
 - Must be current financial members of the club
 - Must pay their competitor levy
 - You must fulfil your patrolling requirements as per patrolling requirements v1.1 document on the DYSLSC website
 - You must seek permission of the board and ski captain and will be allocated a spot if available
- All other financial members may store their board/ski in the board and ski area at DYSLSC under the conditions outlined below:
 - They follow all the conditions as above for patrolling members
 - Must pay a fee equivalent to that of the competitor levy
 - You must seek permission of the board and ski captain and will be allocated a spot if available.
- Non-financial members
 - May not store their board/Ski at Dee Why SLSC

Due to the limited space for storage, priority for storage of equipment will be given in the following order and at the discretion of the board and ski captain:

1. Club owned Equipment for general use
2. Patrolling members who train and or compete
3. Club Coaches
4. Long service members who train and compete
5. Patrolling members that train only
6. Long service members that train only

Members will be notified and given a 30-day period if they have boards or skis in the Dee Why SLSC board and Ski area and do not comply with the above conditions in order to remove their equipment or to become compliant. After this period and if no arrangement can be made with the Board and ski captain, the equipment will be removed from the Board and ski area and left outside.
