President's Report

- Hugh Long

It is with great pleasure that I present the Annual Report for 2019 / 2020 to the 107th Annual General Meeting of the Dee Why Surf Lifesaving Club.

As Surf Life Saving is now an Emergency Service, we got to experience many new aspects of our role in the community during the 2019 / 2020 season. We were called upon to support other Emergency Service organisations during the bushfire crisis and then local flooding. This was a valuable experience for the members involved and I would like to thank all those members who responded to the call.

Our primary function however is and always will be to keep beaches safe and I am pleased to report there were no lives lost on Dee Why beach during patrol hours during this season. Thank you to all the Patrol Captains and the patrolling members for an outstanding effort during the season in keeping the beach safe.

This year will go down in history as one that changed the way we live due to the COVID-19 pandemic and it will affect how we, as a Surf life Saving Club, will function in the future. What that will look like is still to be determined and depends largely on NSW Health guidelines which will be governed by how COVID-19 can be managed and if, or when, a vaccine is developed.

While the future is uncertain and our season ended early there is much to acknowledge from the 2019 / 2020 season.

In late July 2019 our Secretary needed to step down due to work and family commitments and I would like to thank Rowena Clarke for stepping up at short notice and taking on the role for the rest of the year.

The season started well with an open forum for Patrol Captains and patrolling members. The importance of communication was reiterated to all members. The club utilised technology and applications such as Team App that were effectively used by the Club Captain and Patrol Captains to communicate with patrolling members. This ensured we always had the required numbers and members with the appropriate awards on each patrol. It was important that we were well prepared for a busy season.

Dee Why has become one of the busiest beaches in the Sydney Northern Beaches Branch with many visitors coming from outside the area for day trips, weekends and holidays and many of these visitors have little experience with surf beaches and the associated hazards such as rips.

This was highlighted when there were several incidents on the beach shortly after patrol stand down that required response from the club emergency call out team and club members. These incidents were of a nature that they required an ambulance response. Thankfully the final outcome was positive due to the timely response and actions of the club members. These incidents all involved visitors to the area.

Because of these incidents the Club Captain, Matt Molinia, put forward a proposal to SLSSNB and the Council Lifeguards that over the peak period from the start of December to the end of January that a core group, (Patrol Captain, Driver, Crew, ART holder) stay back for an extra hour after the scheduled patrol end time until 7pm. All

the Patrol Captains and key patrolling m e m b e r s supported this unplanned change to the timetable.

The Northern Beaches council also supported the initiative and extended their hours to work with us. We had no further callouts after the end of patrol during this extension period. on Based the high numbers on the beach in the extended hour, it was a worthwhile exercise.



New SRC Graduates Recruiting new Bronze members and the ongoing education of our existing Bronze members is always a high priority. Our CTO, Emily Buckle, has reported that it was another fantastic season for Education at Dee Why with 43 new enthusiastic Bronze and SRC members to Patrol prior to December. Our Summer Bronze and SRC candidates missed out on completing their assessments by one week due to COVID-19 and we hope to get them through by the start of the 2020 /2021 season. Emily continues to work with fellow CTOs from neighbouring clubs and as a collaborative group they have added value to our courses through shared personnel, resources and initiatives.

The 2019 / 2020 season end abruptly on Friday 27 March 2020 when SLSNSW issued a notice to all clubs stating, "Effective immediately, all patrols by volunteer surf lifesavers on NSW beaches will be cancelled for the remainder of the 2019/20 season".

In line with NSW Health and SLSNSW guidelines, our club went into full lock down with no access to members from 27 March 2020 until 26 June 2020.

Our mode of operation changed with the committee meetings being held as virtual meetings using ZOOM, the AGM to be held as combined virtual / in club (with restricted numbers) meeting with the Club presentations immediately following the AGM with the same virtual / in club format. All training and club activities ceased and our annual "end of season extravaganza" was cancelled.

Although patrolling had ceased we were called upon from SLSSNB to provide assistance to the Jet Ski team so they could continue to operate until the end of the season. We provided an area in the club to house the Jet Ski and access to amenities for the Jet Ski patrolling members on the weekend.

As COVID-19 restrictions started to be eased in June we were able to start planning for returning to club activities. We were required to develop a COVID-19 management plan and an implementation strategy which needed to be endorsed by SLSSNB and registered with NSW Health.

I would like to acknowledge Justine Head, the Club Administrative Assistant, for developing, registering and implementing the plans and overseeing making the club compliant to allow us to start moving back to club activities. This was an enormous task which Justine managed seamlessly and professionally, thank you Justine.

As we move forward we will need to be adaptable and resilient in an unpredictable and ever changing environment and I am sure by the time you read this report the situation will have changed.

Our members have been understanding, cooperative and supportive during this difficult period and I would like to thank everyone for their support in helping the club remain compliant with SLSNSW and NSW Health COVID-19 requirements.

Whilst we were unable to hold our annual Club Presentation evening due to COVID-19, congratulations go out to everyone who will receive an award. An awards presentation event for major awards is being planned to coincide with the AGM and will take on a similar format to the AGM with limited numbers in the club and a broadcast of the event over Zoom. A more formal event will be held for the presentation of Club and Bronze awards when circumstances allow.

Due to the restrictions this year the Branch Awards of Excellence was held at Branch HQ in Warriewood with limited numbers able to attend. The event was also broadcast via a live Facebook stream.

Congratulations to the DYSLSC winners and nominees.

Clubhouse and facilities

The Betty Barry Room refurbishment is progressing with the project group under the lead of Dave Lang working with a final design with full specifications, layout and fittings. After the initial consultation with a designer it was decided that a more comprehensive approach was required for a full renovation which would require indepth planning and design. The renovation is scheduled to be completed by the beginning of the 2020/2021 season.

Swan Lounge underwent some maintenance with the floor being sanded and resurfaced and the overhead projector was upgraded.

Allen Lakeman continues to work with the Northern Beaches Council to get approval for the extension of the north end of the club.

The Northern Beaches council has allocated funds for the replacement of the four roller doors on the east side of the club. Funds have also been allocated for painting the club. We expect these projects to be completed before the start of the 2020 / 2021 season.

During the wild storms at the beginning of the year the club sustained damaged to the sails on the Betty Barry balcony, the solar panels on the roof and the newly refurbished Swan Lounge floor. The sails will be replaced and the Swan Lounge floor repaired through insurance due to the damage.

This is always a great experience for the young Life Savers to be able to visit SLSNSW Head Office, CareFlight HQ and patrol at several clubs on the Northern Beaches. This year had a bonus, it was a welcome distraction for many of our fellow Life Savers from the north as that region was heavily affected by the bushfires. Thank you to all the clubs that supported the program and a special thank you to Rowena Clarke (Dee Why) and Gary Hawkins (Mid North Coast) for all their hard work organising the visit.

The club provided volunteers for the annual Beach2Beach (was Pub2Pub) and Sun Fun Run which were coordinated by Justine Head which helps raise funds for the club.

Ocean thunder was back at Dee Why Beach again this year. Three rounds of the event were completed but due to the COVID-19 restrictions the final round has been postponed to November 2020.

On the social scene the club held the usual scheduled events which include the Friday evening BBQ in the Betty Barry room, club Christmas Party on 7 December and the annual Christmas Day pudding hunt.

I can honestly say without the skills I have learnt as a member of Surf Life Saving and without the experience I gained through SurfCom, Club, Branch and State roles I would not have been successful. 2020 has taught us the hard way that nothing in life is a certainty. Get involved, learn new skills, meet new people and find your place in an organisation that can offer you so much.

The 2019/2020 season coincides with the 40th Anniversary of Women in Surf Life Saving and early in the season we were paid an impromptu visit from one of Dee Why's first women surf lifesavers, Wendy O'Sullivan. For those that don't know Wendy and Debbie Lang were the first female members from Dee Why SLSC to receive the award of the Bronze Medallion. Wendy, who resides in New Zealand, popped in briefly to say hi at the half way mark of her Bloody Long Walk.

This season was one that was truly like no other. In November our country was ravaged by Bushfire. The fires continued through December and January and Surf Life Saving was called on to assist those in need. Our friends on the Far South Coast transported stranded locals from the beach to safety. Meanwhile clubs throughout NSW devised plans to assist with donations. In January we were tasked with assisting the Rural Fire Service to provide communications officers at the RFS Headquarters in Homebush manning the 24hr Emergency hotline. Huge thank you to Emily Buckle and Steven Polley who kept me company at Homebush and represented DY and Branch with distinction.

In January we hosted youth from Mid North Coast and Lower North Coast Branch and I had the pleasure of taking some of Dee Why's teenagers out to the Careflight Helicopter base and Wet 'n Wild. We have some amazing young lifesavers at Dee Why and I'm proud to say they represented the club with pride and distinction.

After months of praying for rain the heavens opened in February and all hell broke loose on the Northern Beaches. Large parts of Narrabeen suffered flooding and Surf Life Saving SNB were tasked to assist NSW Police with the evacuation of residents. Dee Why members were quick to volunteer their assistance wading through waste deep water to assist the community. Shout out to Hugh, Matt, Darren, Emily, Tim, Alban and Andrey for their assistance.

So as the flood waters receded and the season looked like getting back on track the World was thrown into turmoil with the COVID-19 pandemic. Strategies of social distancing were introduced and as the pandemic grew for the first time in more than 100 years volunteer lifesavers were removed from the beach. Club Captain's Report

My second season as Club Captain definitely brought up a new set of challenges from fire and flood to plague. This all required additional commitment on our behalf as an organisation that is now part of the emergency services group.

The season started well with the roster going out early and the pre season forum for the Patrol Captains started us off on a positive note. Team App was well used by a large majority of members and it was great to see an increased volume Sub requests and general interaction via the App. More so the fact that I did not receive even one callout during the season for a patrol that was short or in need of an essential award shows the effectiveness of this form of interactive communication.

Becoming a new member of the emergency services group meant that our level of commitment and responsibility needed to increase. With a full season trialling the App, the Captains became much more proficient and compliant in entering stats and information, a necessary requirement with our new responsibilities. It wasn't long into the season that, as an organisation, we were asked to assist with the emergency services in relation to assisting with the fires and with the floods. Several of our members put in additional time to help where requested, whether it was by door knocking and checking on people or assisting with the emergency evacuation on the Northern Beaches. It is really great to see the level of commitment of our members, not only to patrolling but to generally want to assist and help out the community.



In late November and early December at Dee Why we had 2 after hours call outs where there were near drownings of several members of the public, within ½ hour of the patrol being finished. It was decided to look at a solution. Due to the fact that at this time of the year it was still quite warm and light it was deemed that 6pm was too early to finish patrols. After some discussion with the council lifeguards that regularly patrol at Dee Why and discussions with Adrian Hill, Director Of Lifesaving (DOL) a proposal was sent to extend hours during the Christmas to Australia Day peak period. There was full support of the concept from both the DOL and the council with council extending the Lifeguard hours to match, showing the 2 organisations working together harmoniously. An extended hours roster was sent to all Patrol Captains, with minimal notice, outlining the requirements and this was embraced as a good and necessary requirement and all were on board without hesitation. Once again it was great to see our patrolling members, being community minded, not hesitating to take on the additional commitment and responsibility due to a need and for the good of the community.

The Christmas holiday period is an exceptionally busy period on the beach. It was great to see that from a simple request to come down and help out when you can, we received so much support from a large number of the members, especially the recent Bronze groups. One Long Service member in particular, Ron Tyson, newly returned from injury managed to do an entire season of patrols just over that Christmas/New Years break, a mammoth effort and as an IRB Driver, a much appreciated resource on the beach.

Our season was unfortunately cut short due to the COVID 19 outbreak. As the pandemic became more serious and real, measures were taken to manage our members' exposure during this uncertain time, up until the point that SLS ceased all volunteer patrols. For some this did not mean an end to our season. Our afterhours call out teams were on standby and it needs to be noted that on one occasion when an emergency callout message went out 10 of the 12 members of that team were on the beach getting gear and equipment ready within 5 minutes. It was a fantastic response time and effort. During the lockdown the Branch requested to house one of the Jet Skis at Dee Why, being a central and suitable location for support operations. Hopefully we can look to this being a permanent arrangement and encourage more of our members to become Jet Ski operators and demonstrate to the council the need for more space. Unfortunately we have been unable to hold our major club social events, the end of season patrol BBQ and the Presentation Evening but hopefully, once restrictions have been lifted, we can all come back together and celebrate and support each other.

This season, after discussions with the CTO and other key members, it was decided to stop following old requirements for the sake of it. As a forward thinking organisation that does not in any way discriminate against age, race, gender, etc, it was seen as a need to remove this from our awards. As a volunteer, the number of hours a member can do, the awards that they attain or the position they hold is gender unbiased. For that reason, and for the need to propagate equal opportunity, the awards that were previously given out for both male and female - Top 10 Patrollers, SRC Patrol Person, Junior Patrol Person and Senior Patrol Person of the Year will no longer be split into genders.

Our top 10 patrolling members were committed, not only to their own patrols but to patrolling when needed and called upon, especially over the Christmas period.

The Training Group and Club Captains Team will continue to work together to develop multi-skilled Patrols with backup award holders in each position. We will promote higher awards such as ART, Silver Medallion IRB Drivers and Silver Medallion Beach Management and work collaboratively with neighbouring Clubs to ensure ample opportunity for completion. No doubt we will also be adjusting training processes and precautions to accommodate COVID-19 guidelines.

We look forward to growing the training team, mentoring Probationary Trainers in their elected awards and welcoming new Content Experts to enrich the training experience for our members.

Our Training Group is always on the lookout for new members – including trainers, assessors, coaches, content experts and water safety. Please let me know if you would like to be involved. We have a lot of fun and it is a great chance to refresh your skills along the way.

Building and Development Report

- Allen Lakeman

David Spink and Allen Lakeman took an active part in the Committee chaired by Susan Sky.

Following a favourable meeting with the Northern Beaches CEO, Mr Ray Brownlee, on 4 July 2019 to discuss the concept plans prepared by Kinga Monaghan's Sky Blue Building Designs, an application for the Development Application Pre-Lodgement Meeting was made.

The meeting took place on 28 November 2019 with Kinga Monaghan and Allen and six members of staff of Northern Beaches Council including two Planners, a Coastal Engineer, a Stormwater expert, a Development Engineer and a Property Consultant.

In February 2020 the Council provided a nine-page Prelodgement Advice. The major difference of opinion between Council and Kinga Monaghan and Allen was the interpretation that Council has placed on certain parts of the Dee Why Lagoon Wild Life Plan of Management. The Council staff have expressed the opinion that any future Development Application would need to demonstrate not only compliance with the Plan of Management but provide confirmation as to how the increase in floor space approved from the previous development application in conjunction with this proposal collectively was not greater than 30 percent in the floor space from the 2002 baseline.

The view put forward by the Club was that the provisions in the Plan should be read disjunctively and not conjunctively in respect of the earlier expressed authorisation which was said by the Club to be permissive in nature and not restrictive.

On 21 February 2020 Allen wrote to Ray Brownlee seeking a second opinion and further discussions have taken place by telephone.

In October and November 2019, Council officers Owen Mancell and Scot Hedge returfed the area in front of the clubhouse and installed planter boxes along the front fence.

Hugh Long is liaising with Council to replace the roller doors on the ground floor.

Council has also approved the repainting of the clubhouse. An appropriate colour from Dulux Paints has been chosen and the painting was expected to commence later in the year.

Notes of the Financial Statements

Dee Why Surf Life Saving Club Inc For the year ended 30 April 2020

Summary of Significant Account Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009 (NSW), the Charitable Fundraising Act 1991 (NSW) and the Australian Charities and Not-for-Profits Commission Act 2012 (Cth) and the club's constitution. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared in accordance with the requirements of the above acts and regulations, the club's constitution and the following Australian Accounting Standards:

AASB 101 Presentation of Financial Statements

AASB 107 Statements of Cash Flows

AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors

AASB 1031 Materiality

AASB 1048 Interpretation of Accounting Standards

AASB 1054 Australian Additional Disclosures

No other Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets. The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Income Tax

No provision for income tax has been raised as the Association is exempt from income tax under Div 50 of the Income Tax Assessment Act 1997.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

In the event the carrying value of plant and equipment is greater than the estimated recoverable amount, the carrying value is written down immediately to the estimated recoverable amount. A formal assessment of recoverable amount is made when impairment indicators are present.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the statement of comprehensive income during the financial period in which they are incurred.

Depreciation

The depreciation method and useful life used for items of property, plant and equipment(excluding freehold land) reflects the pattern in which their future economic benefits are expected to be consumed by the association. Depreciation commences from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements. The depreciation method and useful life of assets is reviewed annually to ensure they are still appropriate.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised in profit or loss. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result ofpast events, for which it is probable that an outflow of economic benefits will result and that outflowcan be reliably measured. Provisions are measured at the best estimate of the amounts required to ettle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value. Bank overdrafts are presented within current liabilities on the statement of financial position.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Financial Instruments

Recognition, initial measurement and derecognition

Financial assets and financial liabilities are recognised when the Association becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. Financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Classification and subsequent measurement of financial assets.

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments are classified into the following categories upon initial recognition:

- amortised cost
- fair value through profit or loss (FVPL)
- equity instruments at fair value through other comprehensive income (FVOCI)

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within other expenses.

Classifications are determined by both:

- The entities business model for managing the financial asset
- The contractual cash flow characteristics of the financial assets.

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

Subsequent measurement financial assets Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The Association's cash and cash equivalents, trade and most other receivables fall into this category of financial instruments as well as long-term deposits that were previously classified as held-to-maturity under AASB 139.

Financial assets at fair value through profit or loss (FVPL)

Financial assets that are held within a different business model other than 'hold to collect' or 'hold to collect and sell' are categorised at fair value through profit and loss. Further, irrespective of business model financial assets whose contractual cash flows are not solely payments of principal and interest are accounted for at FVPL. All derivative financial instruments fall into this category, except for those designated and effective as hedging instruments, for which the hedge accounting requirements apply (see below).

Equity instruments at fair value through other comprehensive income (Equity FVOCI)

Investments in equity instruments that are not held for trading are eligible for an irrevocable election at inception to be measured at FVOCI. Under Equity FVOCI, subsequent movements in fair value are recognised

in other comprehensive income and are never reclassified to profit or loss. Dividend from these investments continue to be recorded as other income within the profit or loss unless the dividend clearly represents return of capital.

Impairment of Financial assets

AASB 9's impairment requirements use more forward looking information to recognize expected credit losses - the 'expected credit losses (ECL) model'. Instruments within the scope of the new requirements included loans and other debt-type financial assets measured at amortised cost and FVOCI, trade receivables and loan commitments and some financial guarantee contracts (for the issuer) that are not measured at fair value through profit or loss.

The Association considers a broader range of information when assessing credit risk and measuring expected credit losses, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ('Stage 1') and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ('Stage 2').

'Stage 3' would cover financial assets that have objective evidence of impairment at the reporting date.

'12-month expected credit losses' are recognised for the first category while 'lifetime expected credit losses' are recognised for the second category.

Measurement of the expected credit losses is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade and other receivables

The Association makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance at the amount equal to the expected lifetime credit losses. In using this practical expedient, the Association uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

Classification and measurement of financial liabilities

As the accounting for financial liabilities remains largely unchanged from AASB 139, the Association's financial liabilities were not impacted by the adoption of AASB 9. However, for completeness, the accounting policy is disclosed below.

The Association's financial liabilities include borrowings and trade and other payables.

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Association designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities remeasured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss(other than derivative financial instruments that are designated and effective as hedging instruments).

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

Inventories

Inventories are valued at the lower of cost and net realisable value. No value is ascribed to goods for resale that have been donated to the Association where fair value cannot be reliably determined. Net realisable value is the estimated selling price in the ordinary course of business, less any applicable selling expenses.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.






