Dee Why SLSC Life Membership - Adrienne Lowe

Adrienne Louise Lowe joined Dee Why Surf Club in the 2002/2003 season and has maintained her membership since that time.

Adrienne gained her Bronze Medallion in her first year of membership and continued to add awards to her portfolio every season. She obtained her IRB Crew and Silver Medallion IRB Driver Certificate and her Training Officer Advanced Resuscitation in 2003, Silver Medallion Patrol Captain in 2004, Training Officer Bronze Medallion in 2005, Senior First Aid Certificate, Spinal Management and Surf Official Level 1 in 2006, Silver Medallion Basic Beach Management in 2007, Assessor Bronze Medallion and Assessor Advanced Resuscitation in 2008, Assessor ARTC in 2010 and various other awards including training and official awards. She received her 15 Year National Patrol Service Award in 2017 and her 10 Year Assessing, Officiating and Training Certificates in 2019.

Adrienne's passion lies in member education, which involved the conducting of training, assessments and proficiencies for the Club each season. For over 17 years Adrienne has trained Club members for their Bronze Medallion, Surf Rescue Certificate, Advanced Resuscitation and Spinal Management awards, including annual proficiency testing of the members. More recently she has taken the time to induct all Dee Why



SLSC Training Officers and Assessors to the new Bronze Medallion Curriculum and assessed their CPR and Advanced Resuscitation Awards.

She has been an active Patrolling Member/SNB Support Operations Duty Officer from 2002 until and including the current season. She was a Patrol Captain for nine seasons and has amassed 1,323 patrol hours during her career.

Adrienne has held various positions within the Club. The season after joining the Club, she took on the role of Assistant Chief Instructor, moving the following season to Chief Instructor, a position she held until 2007 when she took on the role of Club President. Adrienne then held the position of President from 2007 until 2010. She was a member of the Centenary Committee, the Building Committee and was the OH&S Officer.

She was involved in the Orange Nipper Program, Ocean Thunder and various fundraising events, Coordinated events with Warringah Council for the Australia Day Breakfast at Dee Why Beach and volunteered on the Beach to Bush Program She takes part in the Red Shield appeals for the Salvation Army and is a Cancer Council Daffodil Day Collector.

Adrienne is a mentor to Club Probationary Training Officers and assessors and is one of a handful of Gold Medallion Assessors in Sydney Northern Beaches. She is a facilitator for the Silver Medallion Beach Management Award and as such trained many of the Club's Patrol Captains and Patrol Vice Captains

Adrienne was awarded the Bruce Richardson Medal in her first season, an award presented to a member who achieved and used their awards and new skills to benefit the Club. She was also awarded a Distinguished Service award by Dee Why Surf Life Saving Club in 2020.

Her work with the Club and the Local Community was recognised by Warringah Council in 2010 when Adrienne was awarded Warringah Council's Citizen of the Year. In 2013 she was also presented with a Rotary Brookvale Community Service Award.

In 2014 Adrienne was elected by the SNB Board of Management as Branch Director of Education, a role she proudly held until the end of the 2021/2022 season, when she took on the Mentor Program Advisor Role. She was awarded Outstanding Service, Sydney Northern Beaches in 2018.

In 2013 she was awarded Sydney Northern Beaches Assessor of the Year, New South Wales Assessor of the Year and Surf Life Saving Australia Assessor of the Year.

Adrienne is a thoroughly well-deserving recipient of Life Membership of Dee Why Surf Life Saving Club.

Dee Why SLSC would like to congratulate Adrienne Lowe (DYSLSC Life Member) on receiving the honour of the Order of Australia Medal. Adrienne's commitment to volunteering, primarily for surf lifesaving, but also for many other organisations is phenomenal. This is well deserved recognition for a hard working volunteer.

Adrienne's commitment to Dee Why began in the 2002/03 season when she achieved her Bronze medallion and in her first season, expanded her qualifications and obtained a further 6 SLS awards. Adrienne won the Bruce Richardson Medal in 2003 due to her commitment in achieving and using her awards for the benefit of the club.

Since then, Adrienne has continued her commitment to the service of the organisation and of others in many ways. From an education point of view, Adrienne, by becoming a trainer, assessor, and facilitator, taking on the role of Chief Training Officer and the role of Branch Director of Education, has continued a commitment to the community to ensure education and hence safety. Adrienne led by example as a Patrol Captain and Branch Duty Officer, always there to mentor and assist.



Over and above the prominent and visible volunteer service of training and patrolling, Adrienne also held positions in the Club essential to the development and growth of the organisation such as Chief Instructor, Club President, member of the Building Committee, Club OH&S officer and many other positions that require a great deal of work to be done behind the scenes to ensure the day to day running of the club.

Adrienne also managed to involve herself in other SLS programs. She was passionate about such as the Bush to Beach program educating rural students about the surf environment. Her passion for lifesaving and first aid led her to become an official and competitor in lifesaving events at a national level which involved the culmination of all skills, not just physical, pertaining to the core values of surf lifesaving.

Even though a massive amount of work and commitment was required by Adrienne in her service to surf lifesaving, she still managed to give her time to other organisations and causes such as the Salvation Army Red Shield Appeal where she was an area chairperson, WIRES Wildlife Rescue Service and the Cancer Council Daffodil Day.



Adrienne, as a volunteer, has received many awards prior to this most prestigious honour of OAM including but not limited to Warringah Council Citizen of the Year, SLSA National Assessor of the Year, Bruce Richardson Medal DYSLSC, Club Person of the Year DYSLSC, Outstanding Service SLSSNB Branch, and Dee Why SLSC Life Member.

Even with this honour Adrienne will continue to help others and volunteer her time as she has done for so many years.

Administration Report

What a topsy-turvy 12 months we have had! After just managing to squeeze in our Presentation Night last year, we were once again in lockdown. We then experienced the toughest restrictions we had seen with mandatory mask wearing outside and limited movements for LGA's of concern. 107 days later we finally started to see restrictions easing until we have come to the relative norm that we know today. In February SLSNSW introduced a COVID-19 Vaccination Policy. The logistics of managing this new policy added a level of complexity to my role as COVID-19 Safety Officer and I would like to thank all members affected by this for their cooperation in complying with the requirements of the document. There has been no notification yet if this policy will continue into the next patrol season, but I am sure that SLSNSW will advise us in due course. Fingers crossed that by this time next year there will no further mention of COVID-19 restrictions.

Our two standard fundraising events for the club, the Sun Run and Beach2Beach had mixed results. The Sun Run was held in February and, thanks to all of our wonderful volunteers, we earned \$2,616 for the club. The Beach2Beach was initially delayed from September to March due to COVID-19 restrictions and was then delayed again until August because of bad weather.

Over the course of the year, the Committee has overseen a number of building projects with the refurbishment of the Betty Barry room and the planning process for the extension to the North End Room / storage shed. Both of these projects have presented challenges and the Club has been able to call on expertise from amongst its members to get the best result for the Club.

Despite another challenging year for all, the social aspects of the Club have remained buoyant with the creation of the Silver Salties and a range of events over the year, culminating in the Awards Night which was held at the Club this year. Such events remain an important part of connecting with Patrolling Members and making the Club a community, rather than simply a volunteer surf club.

Member Services Report

- David Spink

Member Services is a new position within the Dee Why Surf Life Saving Club. It is responsible for looking after all Club members, from Seniors to Nippers, and is focused on making the Club more inclusive of all people.

With the help of Emily Buckle, we have developed a strong youth committee which is working on some initiatives to put in place next year. Some of these include an Open Day at the start of the season, a Nipper and Patrol Mentor Group and some beach activities.

Allen Lakeman, Susan Sky and myself have been preparing a DA for the Northern room. The new building works will cover most of the northern driveway making more storage under the club and a lovely big deck facing north. I'd like to thank Allen for all his hard work. Preparing a DA to Council is extremely time consuming.

We have also started a \$150,000 renovation on the Betty Barry Room, and hope to have it finished by the start of the next season.

The Betty Barry Room will become the focal hub of the club, a place where all our members and guests can come together to share experiences, ideas and of course to have fun!

Member Services key role over the next couple of years is to bring all our members together and help them feel they are a part of the Dee Why Surf Lifesaving community.

Building and Development Report

- Allen Lakeman

The members of the Club's Building and Development sub-committee are Susan Sky, Allen Lakeman and David Spink. Despite COVID-19 setbacks, the committee has been progressing with the plans for the extension of the clubhouse.

The proposal is to increase the storage of the clubhouse by the provision of additional area for surf patrol and safety equipment to the northern side of the clubhouse by an area of 6.5 metres by 14 metres. The storage area would be covered by a new deck adjacent to the first storey of the clubhouse of 6.5 by 17 metres. The additional storage will house more IRBs, PWCs, surf safety equipment as well the equipment for the Council lifeguards.

David Spink has been involved in finding and briefing a Coastal Engineer regarding the physical coastal hazards in the design site, including coastal erosion and recession due to sea level rise, wave runup and overtopping. Conceptual management options include piled footings, an emergency warning system and the location of electrical systems above inundation levels.

According to a 2012 report commissioned by Warringah Council (as it was then) historical coastal storms have damaged Northern Beaches infrastructure in 1920, 1925, 1944, 1945, 1967, 1974, 1998 and 2007. Management measures at Dee Why included the construction of the seawall south of the clubhouse. The report concluded that the area north of the seawall including Dee Why SLSC is at particular risk from coastline hazards.

David intends to meet with Council officers later in the year to discuss their requirements for the Lifeguard area in the new storage space and any practical and financial contributions Council can make to the coastal erosion issues.

The committee has obtained a detailed site survey from Warren Bee and the club's architect Fistum Gebera is proceeding with the design plans.

President's Report

This is my second season in this position and the challenges continue. With a strong and dedicated committee and even stronger membership, all putting in a concerted unselfish effort, the impact of lockdowns and restrictions being placed on us due to COVID-19, extreme weather conditions and restrictions on gatherings were minimised and we managed to have a successful season. As a Club we are committed to moving forward, changing, and adapting to our environment. There are no problems, only challenges!

A new and streamlined management structure was implemented at the start of this season that consists of department heads only and includes a specific Surf Sports Department and Member Services Department. As with any new initiative there have been teething problems and as an organisation steeped in history and tradition there is a resistance to change. Some communication issues within the committee and to the membership have been identified and plans have been made to enhance our processes. An overarching Surf Sports Department will hopefully assist in the integration and perceived commitment of our competitors. Members involved in surf sports in our Club have historically had a strong presence on the Management Committee, not just to promote surf sports but to ensure the primary goal of surf lifesaving, drowning prevention, is maintained. We hope to increase the profile of surf sports and make it more available to the wider membership group encouraging them to improve their skills and make them better patrolling members.

The Member Service Department has been designed as the glue that holds all departments together. Its objective is to be the voice of the membership. Included in this department is member protection, ensuring that all members feel comfortable speaking to someone about any issues or concerns. Also included is a group of youth members having an input in shaping the future direction of the Club. Members such as Lia and Rosemary Cooper and Ethan Griffin have done a great deal of planning ready to be implemented next season. Most importantly the social committee, till now unable to be active due to COVID-19 but moving forward will engage with the membership outside of patrols etc.

COVID-19 reared its ugly head again. The impact was widespread. At the start of the season, we were required to wear PPE on patrol and there were restrictions placed on the number of patrolling members allowed on each patrol. Adding to this, it was legislated that all patrolling members, trainers and assessors, age managers etc were required to be double vaccinated. This caused several issues, firstly checking and recording this information and secondly, unfortunately due to this requirement, we had some members who were not either willing or able to comply and hence did not continue their membership. The impact on the Club was also to its balance sheet. Due to lockdowns, restrictions and general uncertainty we were unable to hire out the Club function rooms. Fortunately with restrictions easing early this year interest and confidence in holding functions and events is returning.

On Friday 17th June, SLS Sydney Northern Branch held their awards of excellence. Dee Why had several nominees eligible for these awards including the Club nominating this season for Club of the year. We wished all the nominees as below the best of luck.

Having this relationship with Branch and other clubs has enabled us to work together and share resources. This is beneficial in managing limited resources such as trainers and assessors and being able to run courses such as beach management and ARTC. Most importantly this visibility showcases the opportunities in surf lifesaving and encourages our members to become involved in other aspects of surf lifesaving such as support services or competition that may keep their interest and keep them involved.

Dee Why SLSC is an inclusive club that promotes accessibility and diversity. During the 2021-22 season we received substantial community engagement via the Rainbow Beaches event, driven by our Deputy President Emily Buckle. By adding rainbow colours to our beach and outfits we celebrated all sectors of diversity and highlighted, through colour, that our clubs is diverse, inclusive, and welcoming within all the communities we serve. The celebration was supported by representatives from all levels of government and a letter was received from the Northern Beaches Mayor, Michael Regan, to thank the club for their work in this space. Dee Why SLSC members also participated in the development of the multilingual surf safety resources launched by SLSNSW. Participants were Baha Addeen Aburumman (Arabic); Annikka Burge (Finnish) and Zeynep Soylu (Turkish).

Our Club Captains Team led by Ayman Haggag and supported by his Vice Captains and Patrol Captains did an excellent job in an adverse environment this season, they were well organised and met regularly to ensure they were on top of any issues and to ensure enhanced communication.

The majority of our members were understanding of the situation and keen to be there and do what they could when they could. With nippers starting early at 8am and extended hours negotiated with council in line with daylight savings and peak attendance periods in the summer, our members patrolled the beaches for up to 11 hours in a day split between 2 patrols. The patrolling members were happy to work with

these hours understanding the importance of the Nippers' program running successfully and the importance of community safety and having a patrol on the beach till up to 7pm when the beach was still packed. From this initiative our afterhours call outs have dramatically reduced as most were within 30-45 minutes of the patrol finishing.

Being able to train groups for Bronze, SRC or IRB proved challenging. Between COVID-19 restrictions, poor conditions, cancelled assessments and members requiring isolating, our education team led by Felix Forbes persisted and adapted running additional sessions when the opportunity arose and being flexible with training times and the total course duration. The standard of training and candidates we produced was in no way diminished by the afore mentioned challenges. Even though we may not have had as many candidates this season we certainly have keen candidates of the highest quality.

Nippers once again faced challenges with split shifts and minimising parents on the beach. Our new Junior Activities Coordinator Lee Auzins was well up to the challenge. Finding her feet in her first season she managed a very successful season with a big group of happy nippers and parents. Things can only get easier from here and plans are already underway with more focus on nipper development and less on imposed restrictions.

This seasons competition season was somewhat disrupted. As a club Dee Why for the first time was unable to host the Bennett Board Carnival due to gathering restrictions. We hosted 2 Rounds of the Fast Fives (one from North Curl Curl whose beach was unsuitable), the entire series of Ocean Thunder and set up for The Branch Championships Boat Carnival only to have to pick up and move at the last minute and take the entire work party to Collaroy and run it there. The chaos did not stop there with State Championships being held on the Northern Beaches, only the Juniors ran most of their events. The youth got a start for a few hours and then the rest of the championships was









unfortunately cancelled due to pollution, extreme weather and a gastro bug. Aussies went ahead with a last minute move from Perth to the Gold Coast due to COVID-19 restrictions. Dee Why sent a contingent of 3 youth members, Baelei Rogers, Paris Hudson and Mikey Molinia who represented Dee Why with pride. As with State, many events were cancelled especially in the Opens. Hoping for a better, more consistent season neat season.

One of the honours of being President is being able to give out the President's award. This season it has been awarded to two people, John Collins and Colin Kjoller from Orange. Both John and Colin are worthy recipients with an excess of 10 years of service to Dee Why. They started as parents of children participating in the Junior Development Camp at Dee Why and then stepped up alongside their children and gained their Bronze Medallion. Their level of commitment to the Club has by far exceeded all expectations, not only are they both Patrol Captains on their individual patrols consisting of mainly members from Orange and traveling 4+ hours each way to volunteer, but they also actively encourage new members from that region and surrounds to join and become involved in Nippers and Surf Life Saving. They are both involved in training and put in a great deal of extra work preparing their local candidates with a rigorous schedule, not only in Orange but also in Dee Why on the weekends that they are on patrol. They also travel down at other opportunities just to assist in enabling the candidates to gain additional exposure to the surf environment. John and Colin are an asset to the Dee Why Surf Club and ambassadors to Surf Lifesaving.

I would like to thank all members for their understanding and commitment this season and for sticking with it. Looking forward to a better season where we can focus on club activities and social events.

Our IRB driver and crew of the year showed a great amount of promise. Not only in the boat but putting their hands up when needed and being reliable and putting in the extra time.



Patrol 3 - Dee Why Microburst Storm Event - Logged by Kerry Morris

19th December 2021

The entire team sprung into action and did what was needed to be done to ensure the community and the members of the patrol were safe. We were extremely lucky that no one was hurt, seriously or otherwise. I think back and wonder how this was possible when there were at least 8 Norfolk pines that lost their tops and the flying projectiles including the large seed pods from the pines. The devastation and shock was something that is still very vivid. Three members, Shoaland, Jacqui and Barry along with Dean the Lifeguard, were in the water when the storm hit, seemingly out of nowhere. If it had not been for Matt Molinia seeing the very dark approaching cloud we would have been completely unaware. I had been checking the weather radars all afternoon as a storm had been predicted but no storm cell was apparent. The wind picked up so sharply, the rain, wind and hail were so strong and hard.

The flagged area was located further north than usual (North of the Surf Club) and we had the small tent up as an outpost. A few of the younger members of the patrol came and helped drop the small tent. Fiona, Neill and Matt made the call to drop the large tent and get the patrol and belongings up to the Surf Club with the assistance of Dylan, Leon, Henri Lee, and Sam.

Jacqui, Barry, Shoaland, Dean and myself got everyone out of the water and up the beach. There was one boy who was still in the water and I only noticed him when his father came down to the waters edge and was yelling at him to come out. The boy would have been unable to hear his Dad - the sounds of the storm were so loud. I ran into the water to get to the boy - the wind was so strong and the rain and hail was so hard that it was stinging our skin. I walked the boy out of the water backwards, unfortunately stepping into a hole in the rush to safety and falling, only to be lifted to my feet by a member of the public. The boy reached his father and they disappeared up the beach.

At this time my focus turned to the patrol members in the water. It was like a white-out and all I could see was Jacqui's orange water safety vest and the yellow rescue boards. Dean was also still in the water. Barry was assisting Shoaland. I got to Shoaland and helped hold onto the Board. The wind was strong and it was a struggle to hold on to the boards. Just as I started to think about where was our closest shelter the storm started to ease.

The storm was gone as quickly as it started. The Norfolk pines and been decimated. The beach front path was covered in green, the seed pods and tops of trees strewn everywhere and the water was full of debris. We re-grouped and instructed the team to get footwear on if they had it to attend to the immediate task of checking the area and ensuring everyone was safe. The area behind the playground at the southern area of the beach needed to be secured. There were live powerlines down. Dean was up there by himself doing the best he could. Matt got the bollards out and found hazard tape - Neill, Fiona and others took the bollards up to the area and Henri-Lee and Leon went up to also assist in maintaining the cordoned off area.

Matt launched the IRB with Henri-Lee to do a sweep of the water and check and make sure that there was no one out there. Luckily it was just body boards and other items in the water.

As much of the Northern Beaches had been struck by the same time, Police resources were exhausted and it took some time for Police to arrive. They taped the cordoned off area and then most left to assist elsewhere. The Fire Brigade came and assisted. The members of the patrol assisted in keeping the member of the public out of danger. Some people had little regard of the danger and crossed under the police tape, Henri Lee and Leon witnessed one a man on a push bike, a couple trying to remove their car and 2 people and a dog who, if not for their dog screaming when it came close to a live powerline (possibly receiving an electric shock), would likely have been seriously injured if not worse. They were centimetres away from a live powerline after lifting up the Police tape and walking under it.

Most of the team stayed until 6pm. Other members of the club joined us. Thank you to Graham McVay, Herve, Emily and Chris to name a few.

This will be something that will stay with me and my fellow patrol members for a very long time. Barry and Dean had bruising from the hail! I know I was in a bit of shock and quite emotional after this and Shoaland told me a month or so after the incident that it was scary. All in all we were all very lucky to get off as well as we did under the very trying and sudden conditions.



Notes of the Financial Statements

Dee Why Surf Life Saving Club Inc For the year ended 30 April 2022

Summary of Significant Account Policies

The financial statements cover Dee Why Surf Life Saving Club Inc. as an individual entity. Dee Why Surf Life Saving Club Inc. is a not-for-profit Association incorporated in New South Wales under the Associations Incorporation Act 2009 (NSW).

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009 (NSW), the Charitable Fundraising Act 1991 (NSW) and the Australian Charities and Not-for-Profits Commission Act 2012 (Cth) and the club's constitution. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared in accordance with the requirements of the above acts and regulations, the Club's constitution and the following Australian Accounting Standards:

AASB 101 Presentation of Financial Statements

AASB 107 Statements of Cash Flows

AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors

AASB 1031 Materiality

AASB 1048 Interpretation of Accounting Standards

AASB 1054 Australian Additional Disclosures

No other Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets. The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Income Tax

No provision for income tax has been raised as the Association is exempt from income tax under Div 50 of the *Income Tax Assessment Act 1997*.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

In the event the carrying value of plant and equipment is greater than the estimated recoverable amount, the carrying value is written down immediately to the estimated recoverable amount. A formal assessment of recoverable amount is made when impairment indicators are present.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the statement of comprehensive income during the financial period in which they are incurred.

Depreciation

The depreciation method and useful life used for items of property, plant and equipment(excluding freehold land) reflects the pattern in which their future economic benefits are expected to be consumed by the association. Depreciation commences from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements. The depreciation method and useful life of assets is reviewed annually to ensure they are still appropriate.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised in profit or loss. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value. Bank overdrafts are presented within current liabilities on the statement of financial position.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Financial Instruments

Recognition, initial measurement and derecognition

Financial assets and financial liabilities are recognised when the Association becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Classification and subsequent measurement of financial assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable). For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments are classified into the following categories upon initial recognition:

- amortised cost
- fair value through profit or loss (FVPL)
- equity instruments at fair value through other comprehensive income (FVOCI)

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within other expenses.

Classifications are determined by both:

- The entities business model for managing the financial asset
- The contractual cash flow characteristics of the financial assets

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

Subsequent measurement financial assets

Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The Association's cash and cash equivalents, trade and most other receivables fall into this category of financial instruments as well as long-term deposit that were previously classified as held-to-maturity under AASB 139.

Financial assets at fair value through profit or loss (FVPL)

Financial assets that are held within a different business model other than 'hold to collect' or 'hold to collect and sell' are categorised at fair value through profit and loss. Further, irrespective of business model financial assets whose contractual cash flows are not solely payments of principal and interest are accounted for at FVPL. All derivative financial instruments fall into this category, except for those designated and effective as hedging instruments, for which the hedge accounting requirements apply (see below).

Equity instruments at fair value through other comprehensive income (Equity FVOCI)

Investments in equity instruments that are not held for trading are eligible for an irrevocable election at inception to be measured at FVOCI. Under Equity FVOCI, subsequent movements in fair value are recognised in other comprehensive income and are never reclassified to profit or loss. Dividend from these investments continue to be recorded as other income within the profit or loss unless the dividend clearly represents return of capital.

Impairment of Financial assets

AASB 9's impairment requirements use more forward looking information to recognize expected credit losses - the 'expected credit losses (ECL) model'. Instruments within the scope of the new requirements included loans and other debt-type financial assets measured at amortised cost and FVOCI, trade receivables and loan commitments and some financial guarantee contracts (for the issuer) that are not measured at fair value through profit or loss.

The Association considers a broader range of information when assessing credit risk and measuring expected credit losses, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ('Stage 1') and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ('Stage 2').

'Stage 3' would cover financial assets that have objective evidence of impairment at the reporting date.

'12-month expected credit losses' are recognised for the first category while 'lifetime expected credit losses' are recognised for the second category.

Measurement of the expected credit losses is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade and other receivables

The Association makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance at the amount equal to the expected lifetime credit losses. In using this practical expedient, the Association uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

Classification and measurement of financial liabilities

As the accounting for financial liabilities remains largely unchanged from AASB 139, the Association's financial liabilities were not impacted by the adoption of AASB 9. However, for completeness, the accounting policy is disclosed below. The Association's financial liabilities include borrowings and trade and other payables.

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Association designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss (other than derivative financial instruments that are designated and effective as hedging instruments).

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

Leases

Prior Treatment

Finance Leases were capitalised, recording an asset and a liability.

Leased assets were depreciated over their estimated useful lives. Finance leases were allocated between the reduction of the lease liability and the lease interest expense for the period.

Lease payments for operating leases, where substantially all the risks and benefits remained with the lessor, were charged as expenses in the periods in which they were incurred.

New Accounting Standards Introduced

AASB 16: Leases (applicable to annual reporting periods beginning on or after 1 January 2019) replaces the previous accounting requirements. AASB 16 introduces a single lessee accounting model that eliminates the requirement for lease to be classified as operating or finance leases.

The main changes introduced by the new Standard are as follows:

- recognition of a right-of-use asset and liability for all leases (excluding short-term leases with less than 12 months
 of tenure and leases relating to low-value assets);
- depreciation of right-of-use assets in line with AASB 116: Property Plant & Equipment in profit or loss and unwinding of the liability in principal and interest components;
- inclusion of variable lease payments that depend on an index or a rate in the initial measurement of the lease liability using the index or rate at the commencement date;
- application of a practical expedient to permit a lessee to elect not to separate non-lease components and instead
 account for all components as a lease; and
- inclusion of additional exposure requirements.

AASB 2018-8 Amendments to Australian Accounting Standards – Right-of-Use Assets of Not-for-Profit Entities allows that where the lessee is a not-for-profit entity, the lessee may elect to measure right-of-use assets on a class-by-class basis at initial recognition at fair value in accordance with AASB 13 Fair Value Measurement for leases that have significant below-market terms and conditions principally to enable the entity to further its objectives. AASB 1058 Income for Not-for-Profit Entities addresses the recognition of related amounts.

In addition, where a lessee is a not-for-profit entity and elects to measure a class or classes of right-of-use assets at initial recognition at cost for leases that have significantly below-market terms and conditions principally to enable the entity to further its objectives, the lessee shall disclose additional qualitative and quantitative information about those leases which shall include, but is not limited to, information that helps users of financial statements to assess:

- a. the entity's dependence on leases that have significantly below-market terms and conditions principally to enable the entity to further its objectives; and
- b. the nature and terms of the leases, including:
- i. the lease payments
- i. the lease term
- k. the description of underlying asset; and
- I. restrictions on the use of the underlying assets specific to the entity.

The disclosures so provided by a not-for-profit entity shall be provided individually for each material lease that has significantly below-market terms and conditions principally to enable the entity to further its objectives or in aggregate for leases involving right-of-use assets of a similar nature.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

Inventories

Inventories are valued at the lower of cost and net realisable value. No value is ascribed to goods for resale that have been donated to the Association where fair value cannot be reliably determined. Net realisable value is the estimated selling price in the ordinary course of business, less any applicable selling expenses.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

Significant management judgement in applying accounting policies

When preparing the financial statements, management undertakes a number of judgements, estimates and assumptions about the recognition and measurement of assets, liabilities, income and expenses.

Estimation uncertainty

Information about estimates and assumptions that have the most significant effect on recognition and measurement of assets, liabilities, income and expenses is provided below. Actual results may be substantially different.

Impairment

In assessing impairment, management estimates the recoverable amount of each asset or cash-generating units, based on expected future cash flows and uses an interest rate to discount them. Estimation uncertainty relates to assumptions about future operating results and the determination of a suitable discount rate.

Useful lives of depreciable assets

Management reviews its estimate of the useful lives of depreciable assets at each reporting date, based on the expected utility of the assets. Uncertainties in these estimates relate to technical obsolescence that may change the utility of certain software and IT equipment.

Inventories

Management estimates the net realisable values of inventories, taking into account the most reliable evidence available at each reporting date. The future realisation of these inventories may be affected by future technology or other market-driven changes that may reduce future selling prices.

Long Service Leave

The liability for long service leave is recognised and measured at the present value of the estimated cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

Related Party Transactions

The Association's related parties include its key management personnel and related entities as described below. Unless otherwise stated, none of the transactions incorporate special terms and conditions and no guarantees were given or received. Outstanding balances are usually settled in cash.

Transactions with related entities

The Association sourced goods and services from members at market rate during the financial year. All related party services and contracts are approved by the Committee.

Transactions with key management personnel

All key management personnel and volunteers are not compensated for holding office positions.
